- Entry Limit:** Each swimmer may enter up to three (3) individual events
- Eligibility:** You must hold a current membership at a KYCSL member YMCA. Swimmers must swim the age they are on December 1, 2009
- Awards:** Heat ribbons for all heat winners in the 10 & under age groups. Ribbons awarded through sixth place for individual events. Trophies awarded through fourth place for team scores.

**Scoring:** Individual events 7-5-4-3-2-1  
Relay events 14-10-8-6-4-2

**Coaches Meeting:** There will be a coaches meeting prior to each session. All teams must have a coach or other representative attend.

**Workers:** All teams will be required to provide meet workers. Teams will be contacted later with positions that they will need to fill. These will be based on the number of entries received per team. Teams are also responsible for their own relief workers and stop watches. All certified officials are requested to wear white as a courtesy to all swimmers, coaches, and other officials. All certified workers will be asked to show their certification cards to the meet director at the officials' meeting.

**Take I-75 to Florence, Kentucky**

**Take Exit #181 (Burlington / Florence)**

**If coming from the South:** Turn left at the end of the ramp. You are now on Route 18 (Burlington Pike). Take Route 18 approximately three and one-half miles. R.C. Durr YMCA is on the right just after the intersection of Route 18 and North Bend Road (Route 237).

**If coming from the North:** Turn right at the end of the ramp. You are now on Route 18 (Burlington Pike). Take Route 18 approximately three and one-half miles. R.C. Durr YMCA is on the right just after the intersection of Route 18 and North Bend Road (Route 237).

**If coming from Ashland / Maysville:** Take AA Highway until it ends at I-275 in Wilder. Take I-275 west for about three (3) miles and take I-275 South. Take Exit #181 (Burlington / Florence). Turn right at the end of the ramp. You are now on Route 18 (Burlington Pike). Take Route 18 approximately three and one-half miles. R.C. Durr YMCA is on the right just after the intersection of Route 18 and North Bend Road (Route 237).
